Disclosure – Action to Take

If a child discloses abuse to you:

- Make a **detailed note** of what the child has said as soon as possible.
- Record the **time, date, and location** of the disclosure.
- Inform the **designated safeguarding officer** or welfare officer immediately.
- Contact **Rotherham Social Care MASH** at **01709 336080** if necessary.
- **Do not keep concerns to yourself**—share them with the appropriate authorities.
